Disabled Concession Bridge Card Application Form

Eligibility: The Disabled Concession Bridge Card is available to people in receipt of either the higher rate mobility component of Disability Living Allowance (DLA), enhanced Personal Independence Payments (PIPs), or road tax exemption. The card provides unlimited bridge crossings for a period of up to one year, after which you may reapply for the card to be renewed.

A one-off charge of £10 is made for the issue of this card. To apply you must enclose a copy of your letter of award of DLA or PIP issued by the Department for Work & Pensions, or your mobility supplement exemption certificate issued by the Service Personnel and Veterans Agency.

Disabled Concession Bridge Card – Terms and Conditions for Use

The Disabled Concession Bridge Card must be used strictly in accordance with the following terms and conditions:

1. The Disabled Concession Bridge Card remains the property of the Clifton Suspension Bridge Trust at all times and must be returned upon request.
2. The Card is issued to the person in receipt of the higher rate mobility component of the Disability Living Allowance, enhanced Personal Independence Payments, or Road Tax Exemption for their personal use only.
3. The Card is not transferable. It may not be sold, given or lent to another party.
4. The person benefiting from the concession must be present in the vehicle every time the Card is used.
5. The concession applies to people who live within the Bristol 'BS' postcode area only.
6. The Clifton Suspension Bridge Trust may carry out random checks and investigations to ensure that these terms and conditions are complied with.
7. Any contravention of these terms and conditions will result in the cancellation of the card and the permanent withdrawal of the concession.
